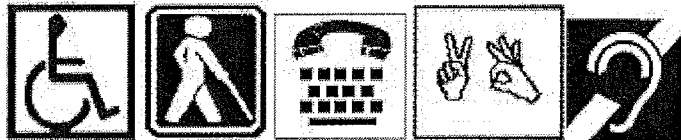
## GUIDELINES FOR TIME LIMITS ON PRESENTATION AND PUBLIC TESTIMONY
