The Flood Control Zone Advisory Board meeting procedure and time limit guidelines are as follows:

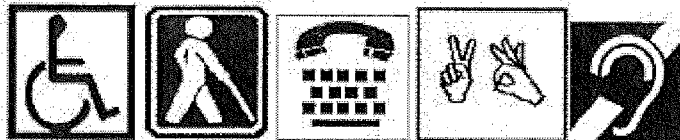
